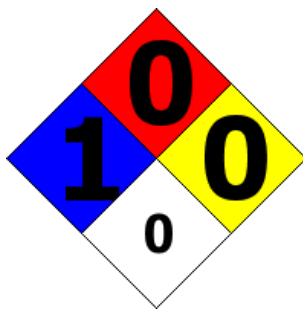

#### SECTION 4 : First aid measures

##### Description of first aid measures

recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter)

### SECTION 7 : Handling and storage

#### Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing.

#### Conditions for safe storage, including any incompatibilities:
