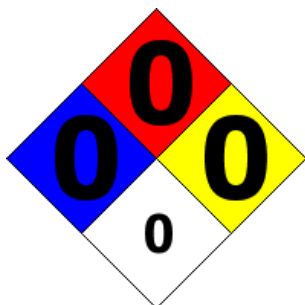

#### SECTION 4 : First aid measures

##### Description of first aid measures

##### Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

##### Advice for firefighters:

### SECTION 7 : Handling and storage

#### Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). 9001-05-2, Catalase Powder, 20,000 units/gm, Contains no substances with occupational exposure limit values.

#### Appropriate Engineering controls:

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling. Provide exhaust ventilation or other engineering controls to keep the airborne concentrations of vapor or dusts (total/respirable) below the applicable workplace exposure limits (Occupational Exposure Limits-OELs) indicated above. Use under a fume hood.
