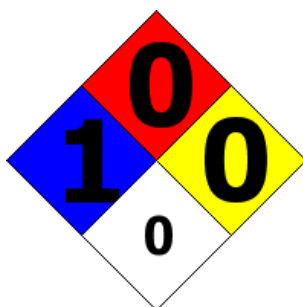

### SECTION 4 : First aid measures

#### Description of first aid measures

**After inhalation:** Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear. Use a barrier device if artificial respiration is given

**After skin contact:** Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Seek medical advice if discomfort or irritation persists. Remove all contaminated clothing/shoes and discard shoes

**After eye contact:** Protect unexposed eye. Remove contact lens(es) if able to do so during rinsing. Seek medical attention if irritation persists or if concerned. Rinse or flush eye gently with water for at least 15-20 minutes, lifting upper and lower lids.

**After swallowing:** Rinse mouth thoroughly. Do not induce vomiting. Have exposed individual drink sips of water. Seek medical attention if irritation, discomfort or vomiting persists. Never give anything by mouth to an unconscious person.

### Chromium(III) Potassium Sulfate

#### Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors.

#### Advice for firefighters:

**Protective equipment:** Use NIOSH-approved respiratory protection/breathing apparatus.

**Additional information (precautions):** Move product containers away from fire or keep cool with water spray as a protective measure, where feasible. Use spark-proof tools and explosion-proof equipment. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Collect solids in powder form using vacuum with (HEPA filter). Evacuate personnel to safe areas.
