After skin contact: Wash hands and exposed skin with soap and plenty of water. Get medical assistance.

After eye contact: Protect unexposed eye. Rinse or flush exposed eye gently using water for 15-20 minutes. Remove contact lenses while rinsing. Immediately get medical assistance.

After swallowing: Rinse mouth thoroughly. Do not induce vomiting. Never give anything by mouth to an unconscious person. Dilute mouth with water or milk after rinsing. Immediately get medical assistance.

Most important symptoms and effects, both acute and delayed:
