Methods for Containment and Clean Up

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Sweep up or vacuum up spillage and collect in suitable container for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

7. Handling and storage**Handling**

Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Empty containers retain product residue, (liquid and/or vapor), and can be dangerous. Keep away from open flames, hot surfaces and sources of ignition. Use only non-sparking tools.
